*This option is only extended to the willing students who do not have any backlog and for such courses where there are no theoretical subjects other than Project, Internship, Portfolio, and Dissertation. A strict online evaluation mechanism has been devised by inviting External expert on the panel and recording of the proceedings. Willing Students should write request mail to HoDs. HoD may consider and recommend for the conduct of On demand online examination as per the prevailing norms.

2. **Minimum Attendance Criteria:** Consider unprecedented situation for the current semester Jan-June 2020, Minimum Attendance criteria has been exempted.
3. The courses where Industrial training and External projects are essential academic components in addition to teaching or Laboratory subjects in the current semester: Industrial training and External projects that are normally given in June-July, Stands postponed till next semester. However, for such courses Odd semester, (AY 2020-21) classes will commence in June 2020 through online mode as per point mentioned in UGC advisory and will complete by Oct 2020 so that students can complete Industrial Training or External Projects between Nov-Dec 2020.
4. The provision of improvement is incorporated if the student wishes to improve grade in particular subject. He/she can appear in special improvement examination in next semester as per university rule.
5. The notice is forwarded to the, Hon'ble Visitor of University (Hon'ble Governor of State of Uttarakhand) and UGC for record.
6. In view of the present scenario and future uncertainties, University may revise and issue fresh notifications as deemed fit.
